

# TCG STORAGE COMPLIANCE TEST APPLICATION

This is the application form to request a test of a storage product by ULINK. The applicant or “Company” needs to complete this application form along with payment for the testing fee and testing devices to ULINK. After test is completed, ULINK will provide a certified test report to the Company.

By submitting this test application, the applying Company agrees to send three devices for testing and agrees to pay the fees outlined in the purchase agreement. If the device fails, ULINK will offer one free retest opportunity within 30 days of the notice regarding the failure.

After the test is completed, ULINK will keep the sample devices for future verification.

The test results and test report will be delivered to the company after the test. If the test is successful, ULINK will post the result on the UTL (ULINK Test List) website. Only passed device will be listed on the UTL.

ULINK, as a TCG registered Test House, may submit the test result to TCG Storage Certification manager for the logo processing. TCG will require a processing fee which is not included in the ULINK Testing Service charge.

The details of test fees and testing support are defined in the purchase agreement.
