TCG Opal Family Certification Test Suite v6.0 Updates

New test – ETC24_ReadWrite_Locked to test Read/Write commands on Locking_Range1 with Read/Write locked according to OPAL-Family Test Case Spec. v1.01

UCT12_Revert_LockingSP, UCT13_Revert_AdminSP, UCT14_Revert_AdminSP_mfgState, UCT15_Revert_AdminSP_Admin1 and UCT16_Revert_AdminSP_PSID: New cases for ZNS device according to OPAL-Family Test Case Spec. v1.01

Enhancements:

- Add the support to retrieve current LBA format before DUT is set to one namespace over full disc
- Add the handling to support the number of UID > 200 in all tables and the number of UID up to 2200 in the ACE table
- SFP08_RevertSP: Add the handling to correctly set the command timeout if the value of RevertTO is set to nonzero in TCGCert_Cfg.txt file
- SPF04_TriesReset: Add the support to retrieve the value in Persistence column and skip the test if the value is TRUE
- UCT01_Discovery: Remove the verification to Geometry Reporting feature according to OPAL-Family Test Case Spec. v1.01
